Standing orders were suspended

The Mayor welcomed Deborah Job from CCBC Community Wellbeing to the meeting who will provide members with an update on the Family Centre and Youth Shedz project.

Deborah informed members that Ysgol Emrys ap Iwan have given part of their building for a family Centre base. The unit will work with residents from Kinmel Bay and the surrounding areas. Families and the schools have been involved in the new development with the colour, feel etc.

The Staff are set to move into the building in August and the service commences from September. There will be a care team visible in the Community for group work and all are welcome. There will also be a wider team working out of the Centre such as family Counselling, and Welfare Rights to offer support at an earlier stage to avoid crises point.

Partnerships have been created with Create a Smile, Canolfan Dewi Sant, schools, Community Police and there will be a Parents Advisory Group. The aim is that the Community will own the family Centre. A pilot has taken place to learn what works in terms of facilities and the process of setting up a family Centre has been a good experience.

Deborah informed members that the name of the Centre is still to be decided and the Town Council suggestions are:

- (a) East Conwy Family Centre
- (b) Dinorben Family Centre
- (c) Abergele Dinorben Family Centre
- (d) Abergele Family Centre
- (e) Abergele & District Family Centre

Deborah informed members that Youth Shedz is a scheme to mentor young people to ensure that it is easier for them to talk in a less formal environment. The Youth Shedz is to be developed in the Cabin at Dinorben and Scott who was originally scheduled to attend is in Cardiff receiving an award for his hard work.

Cllr Bird thanked Deborah for providing members with the update.
