#### 464/08 **Minutes**

It was RESOLVED to APPROVE and SIGN as a correct record the Minutes of the last meeting of the General Purposes and Planning Committee, held on 18<sup>th</sup> December 2008.

#### 465/08 Matters Arising from Previous Minutes:

- a) Library Refurbishment Min. 405/08(c)
  - (i) The date of the official opening of the Library on 29 January 2009 was NOTED.
  - (ii) It was RESOLVED to grant a sum of £20 to fund a prize in a children's competition being arranged to celebrate the Library Open Day
- b) Allotment Provision Min. 405/08(i)
  - (i) It was NOTED that no response had been received to date to the letter sent to the Head of Environmental Services on 17 December to request an update on the search for a suitable plot of land.
  - (ii) It was NOTED that an e-mail reply had been received in response to the e-mail sent by Cllr. Sam Rowlands to Stan Yates, CCBC, regarding

the lack of mention of the waiting lists for allotments in the recent LDP display for County Councillors.

It was RESOLVED to write to the Head of Environmental Services and the LDP Officer to confirm that the up to date waiting list had been received and that the need for allotments would now be considered as part of the LDP process.

It was FURTHER RESOLVED to mention that this Council is looking into a pilot project which aims to identify property owners with surplus garden space to help meet the demand for allotments and to suggest that a policy in the LDP to help prevent building on large garden plots would assist with this.

c) New Play Equipment for Parc Gele – Min. 405/08(j)

It was NOTED that the installation of the new equipment is scheduled for the middle of February.

d) Pentre Mawr Park – Min.405/08(f)

It was NOTED that a meeting has been arranged on Thursday 29<sup>th</sup> January to discuss the protection measures for the park and members of the Parks & Play Areas sub-committee have been invited to attend.

- e) Morfa Rhuddlan West Flood Partnership Group Meeting

Cllr. Tim Rowlands gave a brief verbal report on the meeting held on 22 January 2009, the main interests being flood resilience, planning and evacuation in event of flood. Concern had been expressed regarding an application by a large caravan camp in the area for a 12 month licence and the impact this may have on evacuation planning, especially if more sites were to follow suit.

It was NOTED that further consideration was to be given to this matter after the Action Plan is drawn up for the next meeting in April.

It was RESOLVED to write to Darren Millar AM, with a copy to Mr Iwan Davies, expressing further concern that this appointment is not considered to be democratic and seeking the view of the Welsh Assembly Government.
