488/09 Visitor to the Council

The Chairman welcomed Celia Williams from Crest Cooperative to the meeting to deliver a presentation on the work that Crest carry out locally.

Celia advised that Crest is a self-sufficient community business and operates four recycling sections namely, Community Recycling, Trash and Carry (arts and crafts), Against the Grain (wood recycling) and Ragamuffins (textile recycling). Crest work in conjunction with Social Services and the Probation Service providing training and work opportunities for local people. Recycled goods are sold in their shop in Llandudno Junction. Crest, in conjunction with Fairshare North Wales, are presently researching the possibility of distributing quality surplus food to those suffering food poverty.

The Chairman thanked Celia Williams for her very informative presentation.

It was RESOLVED to receive, approve and sign as a correct record the Minutes of the last Ordinary Meeting, held on 4th February 2010

490/09 <u>Matters Arising from Previous Minutes:</u>

a) Future Burial Provision – Min. 350/09(a) It was NOTED that Mr Jim Graham of Mott McDonald had been appointed as Consultant to research suitability of land for future burial provision. County Councillors were requested to pressurise CCBC to make a decision in this matter.

It was RESOLVED to write to Mr Lyn Davies to establish if Mr Gethin Morgan is now the appointed Project Manager, and if so, that he be invited to a Council Meeting to update Members.

b) Proposed Gating Order – Min. 454/09(a)

It was RESOLVED to suspend Standing Orders to allow County Councillor Ron Hastings to address the Council.

Cllr. Hastings made a request, on behalf of the residents of Castle Place / Groes Lwyd, that the gates are not left open during the day but remain closed, as problems with youngsters congregating and drinking in the alleyway are as bad in the daytime as at night. A local resident, who was also present, confirmed this to be the case.

It was RESOLVED to fully support the permanent gating of the alleyway.

 - (i) It was NOTED that Peter James, Strategic Lead Officer for Housing, NW Coast SRA, will be attending the April Ordinary meeting (to be held one week later than normal, on 8th April) to give a brief presentation and answer any questions.

It was NOTED that the PCSOs are currently attending the schools at the beginning and end of each school day to remove any vehicles which are causing an obstruction.

It was RESOLVED to write to Insp. Essi Ahari to query why the CBM is being taken away from community policing issues, such as this, to cover night duties for other Officers.
