It was PROPOSED that Cllr. Sudlow is elected as Chairman.

28/13 Matters Arising from previous Minutes

- (a) On-going Agenda item – the installation of Blips and Bollards in the Town Centre and an update from Will Roberts regarding loading and unloading in the Town Centre. **It was RESOLVED to request that a quotation is obtained for the provision of bollards in the Town Centre, with St Asaph sighted as a good example of the type of installation. It was FURTHER RESOLVED to support the request for dual use of the taxi rank for loading and unloading purposes.**
- (b) On-going Agenda item – update regarding the LDP. Members provided an overview of the findings from the recent inspection meeting as follows:
 - Disappointed that the only amendment to the traffic problems in the Town Centre was a ‘tweak’ to the traffic lights.

- The inspector will look into the provision of Extra Care Housing in the allocation
- Cllr Wood was requesting support for the playing field to be reclassified with village green status.
- Cadnant Planning have proposed 200 houses on the Business Park

Members gave a vote of thanks to Cllr Wood and Cllr Waters for their hard work.

It was NOTED that Cllr T Rowlands would be providing an update regarding Gypsy Travellers

- (c) The Clerk confirmed that no update from Highways had been received regarding the Pensarn Beach Car Park. **It was RESOLVED to contact Highways for an update for the next meeting.**
