It was RESOLVED to RECEIVE, APPROVE and SIGN as a correct record the Minutes of the Ordinary Meeting of the Council, held on the 3rd December 2015

- (a) An update from CCBC with regard to the proposed waiting times at the Library Car park was RECEIVED. The Clerk informed members that the closing date for call was today and the matter can now be forwarded to Legal to processing.
- (b) An update from Conwy Planning with regard to the recent request regarding Planning application number 0/40507 was RECEIVED. Members requested clarification as to why the roundabout does not appear as part of the development, which is situated on the marsh area of the land. Members also requested further clarification regarding the stop up of St George Road, as the matter may not form part of the Anwyl development but sit outside of it and what the difference is?
